FIRST CUMBERLAND PROPERTIES – NOTICE OF SECURITY INCIDENT October 26, 2022

First Cumberland Properties ("FCP") is providing notice of a recent incident that may have impacted the security of personal information. The confidentiality, privacy, and security of information in FCP's care is one of its highest priorities and FCP takes this incident very seriously. Although FCP has not received any reports of actual or attempted misuse of the impacted information, FCP is providing this notice in an abundance of caution. This notification provides information about the event, FCP's response to it, and resources available to individuals to help protect their information, should they feel it necessary to do so.

What Happened? On October 7, 2022, FCP learned of suspicious activity on its computer network. Upon discovery, FCP notified law enforcement and began an investigation, which included working with third-party consultants to determine the full nature and scope of the incident and to secure the FCP network. As a result of its investigation, FCP determined that personal information was potentially subject to unauthorized access and/or acquisition during the incident. Accordingly, FCP conducted a diligent review of the information stored on the impacted systems to determine what personal information, if any, was potentially affected.

What Information Was Involved? The investigation determined that one or more of the following data elements may have been accessed and/or acquired by an unauthorized individual, if this information was provided to FCP: your name, address, date of birth, Social Security number, financial account number, and government issued identification.

What Is FCP Doing? We take this incident and the security of personal information in our care very seriously. Upon learning of this incident, we moved quickly to investigate and respond to this incident, assess the security of our systems, and notify potentially affected individuals. As part of our ongoing commitment to the security of information, we notified federal law enforcement and are reviewing and enhancing existing policies and procedures to reduce the likelihood of a similar future event.

What You Can Do? While FCP is not aware of any actual or attempted misuse of information as a result of this incident, FCP nonetheless encourages you to remain vigilant against incidents of identity theft and fraud by reviewing your account statements and to monitor your credit reports for suspicious activity. Under U.S. law individuals are entitled to one free credit report annually from each of the three major credit reporting bureaus. Individuals may also contact the three major credit bureaus directly to request a free copy of their credit report, place a fraud alert, or a security freeze.
